INTER-ORDANIZATION PROGRAMME FOR THE SOUND MANAGEMENT OF CHEMICAL

### **Background**

A number of countries have initiated the development of an *Integrated National Programme for the Sound Management of Chemicals (INP)* in collaboration with UNITAR/IOMC and with funding of the Swiss Government. The integrated chemicals management concept involves the establishment of a national collaborative platform which formalizes interministerial coordination and ensures systematic stakeholder involvement. The platform serves as a framework to develop National Chemical Management Profiles, to strengthen national information exchange and to develop a coordinated financial resource mobilisation strategy, for example. It also facilitates coordinated action plan development for substantive areas which benefit from integrated approaches, such as establishment of poison control centres, GHS implementation or capacity building for integrated import control. An important aspect of developing an INP is the identification and implementation of synergies for capacity building under international chemicals management agreements.<sup>2</sup>

#### Objective of the Side Event

The side event has the objective to brief SAICM delegates about the INP concept, to share practical experience gained in countries, and to facilitate a discussion regarding the ways in which the concept may be relevant for the further development of SAICM.


# Organization
